IV. Chair's Report: Osborn reported that the graduate school minimum requirements approved by faculty senate.

V. Old Business

1. Vice Chair --- There were no nominations for Vice Chair. None again.
2. Second Readings
 - a. School of Education Proposal: Direct Admission to LSU Luttrill & Pearl Payne School of Education. Presented by Eugene Kennedy and included a document answering questions from the committee. Document pasted below minutes. Creating a cohort helps with mentorship (both peer and faculty) which is important for students. Direct Admission allows for earlier learning experience and observations in school, access to Stipends and scholarships. Discussion centered on why lowering the grade point average. Others with direct admit programs spoke about the benefits of direct admit. Question asked if faculty voted on this and answered with a yes, almost unanimously. Maiti moved to approve the proposal, Dietz seconded. 8 of 9 voted yes. Motion passed.

b. PGL Grad School Proposal: Eligibility of Faculty & Staff for Graduate Degrees. Calamia presented that changes are needed to the eligibility of LSU faculty to pursue advanced degrees at LSU. [Note – this is NOT the Educational Leave policy in which LSU Faculty apply for a LEAVE from LSU to pursue an advanced degree elsewhere.]. The change allows LSU faculty, including Instructors, to pursue advanced degrees at LSU with conditions that teaching and serving on student committees in the department in which the faculty is pursuing a degree is prohibited and that conflicts of interest surrounding the promotion and tenure process be avoided and that a plan to avoid such conflicts be included in the application materials. The idea is about getting ahead of grievances that could arise. Calamia stated that there was previously a policy that was more restrictive. They can still teach Undergraduates but not graduate students. Church moved to approve the proposal, Gregg seconded. Unanimous approval. Motion passed.

VI. New Business –First Readings

1. PGL Grad School Proposal: Change Graduate School Regulation Regarding Remediation of I grades for Students in Online Degree Program Courses. PGL Grad School Proposal: Change Graduate School Regulation Regarding Remediation of I grades for Students in Online Degree Program Courses. Paul Manthei presented this request to change the Graduate School regulation regarding the remediation of “I” grades for students in online degree program courses. The proposed regulation brings their time closer to the minimum time offered to on-campus students to remediate “I” grades with the aim of reducing the failure rate in online courses and promoting student success in online degree programs. This has been an ongoing issue for the past two years. A previous proposal was rejected. Delzell spoke in support of the proposal due to the tighter time period and because it is stated precisely. Catalog language on online students is too vague. Language in catalog doesn’t mention which students –live or online; undergraduate or graduate student. This proposal is to standardize it for all, though this one is simply for the online graduate students. Maiti made motion to suspend second reading, Dietz seconded. Unanimous approval. Gregg made motion to approve the proposal, Rollins seconded. Unanimous approval. Motion passed.

VII. Maiti made a motion to adjourn. The meeting adjourned at 3:53 pm.
